City Manager Nathan McKenna presented a Resolution Approving an Agreement with James Superior Cleaning LLC for Janitorial Services. The City received one proposal for this service. James Superior Cleaning LLC is owned by the sons of Jason James, our current janitorial service provider. The services are the same and include cleaning of City Hall, Public Works offices, Tourism office, and the Police Department. The total cost per month is \$5,700. That is a \$25 increase over what we pay monthly now. Staff recommendation is to approve the agreement.

MAYOR

Mayor John Lewis stated one of the best things that he and the Council can do is recognize the hard work that our first responders in this community do. Mayor Lewis then turned the meeting over to Police Chief Robert Brands for presentation of Officer of the Year.

Chief Brands stated that one of the best things he does each year is to present the award for Officer of the Year. There are many hard-working men and women at our Police Department including administrative staff, telecommunicators, and officers who make a big impact in our community. This year there were two nominees who were both nominated last year and have consistently had high standards over several years. The officer chosen this year was Officer Brenton Deadmond. He has been with the Mt. Vernon Police Department for a little over 3 years. He's made a big impact on the department. Sargent Pendley nominated Officer Deadmond stating that he always displays a positive attitude. He brings questions or concerns to his supervisors in a respectful manner and is open to discussion. Officer Deadmond has pushed himself and gone through field training school and has started training officers. He provides quality training to new hires so they understand the law and policies. In addition, he obtained his drone pilot's license and joined the MVPD's High Risk Team support unit. He has also become a high-risk traffic stop instructor. He is always looking to conduct training with the shift to maintain a high quality of understanding of procedures and expand officers' abilities to conduct their job in a safe manner. Officer Deadmond pushes trainees to be proactive and gain as much experience as possible before they are released on their own. He has a large amount of respect

from his fellow officers. He has displayed a vast amount of knowledge, has shown an interest in advancing himself within the department, and is currently on the corporal list for promotion.

As Officer Deadmond accepted the award, he thanked his wife and family for their support and also stated he works with a great group of people at the MVPD. He stated they constantly push each other to be the best they can be and do training to try and improve themselves.

Mayor Lewis congratulated Officer Deadmond on being named Officer of the Year and called it a job well done and very well deserved.
