Each bid shall be accompanied by a set of "Specifications" consisting of a detailed description of the equipment.

PURCHASER'S OBLIGATIONS

The purchaser reserves the right to accept or reject any or all bids on such a basis as the purchaser deems to be in its best interest. All bidders shall be advised that the purchaser is not bound in any manner to automatically accept the lowest bid. The City Council reserves the right to reject any and/or all bids and to accept which is most advantageous to the City of Mt. Vernon.

ACQUAINTANCE WITH SPECIFICATIONS

It is the responsibility of the bidder to review all the bidding requirements. The failure of a bidder to be acquainted with this information shall not relieve them of any obligations of the bid requirements.

BID FORMS / SPECIFICATIONS

All bid forms shall be submitted on the attached bid form. The bid form and / or these specifications shall be filled out by checking either the "YES" or "NO" column for each section / paragraph. Failure to use this form and / or these specifications shall be cause for immediate rejection of any bid.

EXCEPTION TO SPECIFICATIONS

The following specifications shall be strictly adhered to. Exceptions shall be allowed if they are equal to or superior to that specified (as judged by the purchaser), and provided they are listed and fully explained on a separate page entitled "EXCEPTIONS TO SPECIFICATIONS". Each check in the "NO" column shall be listed and fully explained. If a section contains an empty column, where the bidder neglected to check the proper "YES" or "NO" column, it is assumed the bidder is not conforming to the requirements of this bid. If no explanation is given in the "EXCEPTIONS TO SPECIFICATIONS" document the bid is subject to immediate rejection.

DELIVERY AND SETUP

Delivery and setup to the City of Mount Vernon will be <u>included in the bid price</u>. Delivery date must be submitted on bid sheet.



SPECIAL NOTE

Due to recent issues with surcharges and upcharges, bidders should anticipate fluctuations in prices. The awarded bid shall be strictly adhered to; all pricing shall be final. Any extra charges or price fluctuations shall be the responsibility of the bidder and not of the purchaser. <u>Any charges incurred after the award of the bid will only be paid by the purchaser if modifications or additions are made by the purchaser after the bid has been awarded.</u>
