1. NO alcohol is allowed on park premises.

2. A 50% deposit must be made at the time of reservation. \$25.00 is non-refundable. The remaining 50% balance is due within the next 30 days. Any cancellations made within 30 days of the event date will result in the forfeiture of the entire reservation amount. If a reservation is made within 30 days of the event date, the full payment of 100% is due upon reservation and is non-refundable. It is the responsibility of the client to ensure timely payment and to adhere to the terms outlined. Failure to make

payments according to this policy may result in the cancellation of the reservation without a refund.

3. Game must be completed by 10:30 p.m. No exceptions. Lights will be shut off at 10:30 p.m.

4. Rain Policy: Use of fields may be prohibited 24 hours after rain. The use of the field **will** be prohibited after heavy or extended rain. Park staff will have the ability to cancel games and will NOT provide drying materials for field preparation. Refunds will be handled on an individual basis depending upon weather cancellations.

5. The Parks and Recreation Department will be the sole provider of concessions at the site. We also have the right to prohibit coolers from premises or charge a fee for coolers to be brought into the facility.

6. The Parks and Recreation Department is NOT responsible for finding umpires or providing equipment.

7. Host must provide a \$1,000,000.00 insurance policy listing the City of Mt. Vernon as an additional insured. The policy must have dates of the events listed or be included if coverage is for the entire year.
