City of Mt. Vernon, Illinois Regular City Council Meeting Monday, October 6, 2025 - 7:00 p.m.

The Mt. Vernon City Council held a Regular City Council Meeting on Monday, October 6, 2025, at 7:00 p.m. in the City Council Chamber at City Hall, 1100 Main Street, Mt. Vernon, Illinois. Facebook Live: https://www.facebook.com/MtVernonIL.

Mayor John Lewis called the meeting to order at 7:00 p.m.

Pastor Ron Lash with the Corinthian Baptist Church led the Invocation.

The Pledge of Allegiance was recited.

ROLL CALL

The roll call showed present: Council Member Joe Gliosci, Council Member Donte Moore, Council Member Jay Tate, Council Member Mike Young, and Mayor John Lewis

PRESENTATION OF JOURNALS

The Journal for September 15, 2025 Regular City Council Meeting was presented for approval.

Council Member Joe Gliosci motioned to approve the Journal as presented. Seconded by Council Member Donte Moore. Yeas: Gliosci, Moore, Tate, Young, and Lewis.

VISITORS/CITIZENS REQUESTS/ADDRESSES FROM THE AUDIENCE

Willie Johnson spoke to the Council regarding his concerns with the location of the new Dutch Bros Coffee on Sunset Drive. He stated he is a 40-year resident of that neighborhood and that Sunset Drive is a narrow street with a dead-end cul-de-sac, and the only exit off of Sunset is onto Broadway. He said that he and other neighbors believe this is going to be a major disruptor of the neighborhood and that this establishment is going to cause a lot of difficulties for the Sunset Drive residents. He stated he was shocked that the people who live on that street were not apprised of what was to take place at that location and that the residents were not given much thought in this situation.

City Manager Nathan McKenna stated that the property has been zoned for commercial development for years and that the property did not have to go before Planning and Zoning Commission. He affirmed that most of Broadway frontage properties are zoned commercial. The site plans were submitted to the City Engineer for evaluation and everything conformed with the state and local codes. McKenna also stated that the property had been for sale for some time and it was advertised as zoned for commercial purposes. McKenna also stated that in addition to the entrance and exit on Sunset Drive, there will be an exit onto Crownview from the drive-thru coffee shop that can be utilized by its patrons. Mayor Lewis added that the zoning changes happened 25 years ago and that the City doesn't choose what businesses come to town. Mayor Lewis thanked Mr. Johnson for his comments.

APPROVAL OF CONSOLIDATED VOUCHERS FOR ACCOUNTS PAYABLE

BIDS/QUOTES

City Manager Nathan McKenna presented the Bid Results for the Richview Road Sewer Main Replacement. The City received two bids for this project. J.K. Trotter was the lowest bidder with a bid of \$300,427.00. Staff recommendation is to award the bid.

City Manager Nathan McKenna presented the Bid Results for a Skid Steer for Public Works. This was a budgeted expense in the Home Rule Fund. The City received five bids, two of them did not meet bid specifications. Diamond Equipment was the lowest bidder with a bid of \$83,500. The City had budgeted \$107,000 for this equipment. Recommendation is to award the bid to Diamond Equipment.

Mayor Lewis stated that the Inspections Office can look into that. Mr. Petties said he appreciates the progress that the Mayor and Council are doing and making Mt. Vernon a good place to live. The Fall Fest was good, and the kids really enjoyed themselves. He stated that he was proud of the Veterans Park and believes we have one of the greatest parks in the area and also in the downtown area.
