Mobile Food Vendor Permit or Itinerant Vendor License from the City. A preliminary list must be submitted not less than 7 days before the rally and a final list must be submitted not less than one day before the rally; issuance of a Permit is conditioned upon submission of the final list, and failure to submit the list shall void the Truck Rally Permit.

The person applying for this License swears that the contents are, to the best of their knowledge, true, that the Operator has read Section 11.18 of the City of Mt. Vernon Revised Code, and that Operator will comply with all applicable requirements.
